## POLICIES

1. Child's age must be 8, 9, or 10 on July 25, 2011 to attend Camp I. Child's age must be 10, 11, or 12 on August 1, 2011 to attend Camp II.
2. If a child does not appear on the first day of the camp at 8:30 a.m., that child will be dropped from camp and the position will be given to an alternate child unless prior arrangements are made with LLTT.
3. LLTT reserves the right to dismiss any camper whose behavior is not appropriate to the atmosphere and expectations of LLTT or the camp director.
4. LLTT reserves the right to cancel any session of camp for any reason, although every effort will be made to avoid cancellation. Should a camp be canceled for any reason, a parent or child is not entitled to any compensation for canceled session.
5. Under no circumstances are campers allowed to bring valuables, weapons, collectables, radios, i-pods, or other electronic devices. If a cell-phone is necessary, it must remain OFF unless a camp leader supervises its use. All these items are subject to confiscation. LLTT is not responsible for such items if brought to camp. Campers in possession of any weapon will be removed from camp.
6. Children must be dropped off between 8:15 a.m. and 8:30 a.m. at the Susanville Railroad Depot or other designated site each day and promptly picked up at 3:30 p.m. by an adult each day at the Susanville Railroad Depot or other designated site.
7. LLTT staff and volunteers will administer basic first aid as needed.
8. LLTT will provide lunch, water, sunscreen, and bug spray. If your child has any special needs, it may be your responsibility to provide their materials. Please be sure your child is dressed appropriately for the day. Recommended attire includes closed-toed shoes, a hat, and a long sleeved shirt. Additional water-appropriate shoes may accompany the child.
